AXA IM Alts selects Gordon Ramsay Restaurants for the UK's highest restaurant and bar

- Lucky Cat and Bread Street Kitchen to open at the top of 22 Bishopsgate, 269 metres above ground.
- Offering will also include an open-air terrace, private dining concept and a central location for the Gordon Ramsay Academy.
- The five culinary experiences will occupy floors 58M, 59, 60 and 61 and will sit above Horizon 22, the recently opened free public viewing gallery.

AXA IM Alts, a global leader in alternative investments with €183 billion of assets under management^[1], announces that Gordon Ramsay Restaurants will open what will be the UK's highest building top bar and restaurant offering^[2] at 22 Bishopsgate in London. Gordon Ramsay Restaurants has taken a 20 year lease on levels 58M, 59, 60 and 61 of 22 Bishopsgate, directly above Horizon 22, the recently opened, and Europe's highest, free public viewing gallery^[3].

The 2,263 sqm (24,361 sq ft) space will welcome *Lucky Cat by Gordon Ramsay*, an Asian inspired restaurant, influenced by Tokyo's 1930s kissas and Shanghai's drinking dens, and the contemporary British cuisine at *Bread Street Kitchen*. The *Lucky Cat* open-air rooftop terrace will be the destination for cocktails and entertainment until 3am.

22 Bishopsgate will also feature a new 14-seat Chef's Table concept born from the Gordon Ramsay Restaurant's first establishment, *Restaurant Gordon Ramsay*, which has maintained a 3-star Michelin rating for 22 years. Meanwhile the acclaimed *Gordon Ramsay Academy* will open its first central location where passionate cooks can hone their culinary skills.

Each venue will have breathtaking views of the London skyline, with vistas of iconic landmarks including Tower Bridge and St Paul's Cathedral across the various levels. There will be dining and entertainment for all occasions.

This new leisure offering represents another first for 22 Bishopsgate, having already opened London's first climbing window, in the 25th floor gym, and Europe's highest free public viewing gallery on level 58. This unique 'vertical village' also incorporates over 100,000 sq ft of integrated amenity and social spaces including a fresh food street-market style restaurant offering on the second floor, an innovation hub, wellbeing retreat and spa, curated 'art walk', business club as well as a c. 1,500-space active commuter park and cycle hub.

22 Bishopsgate is a people-led smart building, designed to meet the changing needs of the modern occupier and embody the structural and cultural shifts in how people work and live. Its occupier and consumer offering demonstrates a continued commitment to grow a thriving community, bringing together a diverse range of tenants and visitors across numerous sectors and walks of life in the heart of the City of London.

Gordon Ramsay said of the announcement: "This is more than just a new opening – it's a significant milestone for our business. We're not only launching the highest culinary experiences in London but also creating a vibrant culinary hub at the impressive



22 Bishopsgate in the heart of the city. I would like to thank all our partners, including Barclays, for their support and I cannot wait to share this unique dining experience with our guests".
